## **Tuition Payment Policy**

- The applicant agrees to pay FULL tuition the first week of each month without being invoiced, whether the student chooses to attend classes or not. Tuition is never Pro-rated.
- Tuition is NON-REFUNDABLE and cannot be extended to the next session or term.
- Students will not be allowed into class if tuition payments are more than 2 months behind. Holidays and snow days are covered by months that have 5 classes in them.
- New Students who start classes mid-month have the option of paying either the full month's fee or the individual class rate, until the next month begins.
- Classes are discounted only when paying for the full month

  (*Example*: \$50/month divided by 4 classes = \$12.50 per class. However, that discounted rate is only given when paying for a full month. Individual classes are either \$15 or \$25)

#### **Studio Information**

Classes run from September through June. Please adhere to the class uniform dress code as noted on our website. The class schedule may be subject to change at any time, as we require a minimum of 6 students per class. Consistent attendance is encouraged and expected. Make-up classes are not offered. For inclement weather, CBC follows Bloomington Public Schools emergency and weather related closings. Our Spring Recital will be held mid June and new this year is a Winter Recital to be held in December. Anticipate student costume fees for each recital.
