Notice and Agreement

Insurance Clause

The applicant, and, if appropriate the applicant's parent and/or guardian acknowledges that there does exist in the study of dance some risk of injury. It is the applicant's responsibility to fully disclose to his or her instructor(s) any circumstances which might place the applicant in jeopardy of injury.

The applicant, as additional consideration for the student's instruction, hereby releases Continental Ballet Company and its instructors and staff, from liability for injuries to the person or property of the student, which may occur while participating in its activities. The undersigned further agrees to indemnify Continental Ballet Company for any damages, including attorney's fees, in the event any claims are asserted against it arising from the student's participation in its activities.

Tuition Payment Policy

The applicant agrees to pay FULL tuition the first week of each month without being invoiced, whether the student chooses to attend classes or not. A \$10 late fee will be charged if a tuition payment is submitted after the 10th day of the month. Tuition is never Pro-rated and is NON-REFUNDABLE. It cannot be extended to the next session or term. Students will not be allowed into class if tuition payments are more than 2 months behind. Holidays and snow days are covered by months that have 5 classes in them. Classes are discounted only when paying for the full month (for example: \$55/month divided by 4 classes = \$13.75 per class. However, that discounted rate is only given when paying for a full month. Individual classes are either \$15 or \$25). *New students who start classes mid-month have the option of paying either the full month's fee or the individual class rate, until the next month begins.*

Studio Policy

Classes for the regular school season run from September 2024 through June 2025. Please adhere to the class uniform and dress code as noted on our website. The class schedule may be subject to change at any time, as we require a minimum of 6 students per class. Consistent attendance is encouraged and expected. Phones are *Not allowed* in class. Make-up classes are not offered. For inclement weather, CBC follows Bloomington Public Schools emergency and weather related closings. Our Spring Recital will be held mid June and new this year is a Winter Recital in December. Anticipate student costume fees for the spring recital; student participation is encouraged for each.
